In 2022 – 2023, The Treaty Relations Commission of Manitoba (TRCM) is offering the following five synchronous online sessions:

In-person events for 2022-2023

Chief Cadmus Delorme

Chief Cadmus discusses the road to reconciliation October 20, 2022 (Evening Event)

Chief Cadmus Delorme, a Cree and Saulteaux, is the Chief of the Cowessess First Nation. Chief Delorme graduated from Cowessess Community Education Centre in 2000. He later moved to Regina to pursue a Bachelor of Business Administration and a Certificate in Hospitality, Tourism and Gaming Entertainment Management from the First Nations University of Canada (FNUniv), and a Master of Public Administration from the Johnson Shoyama Graduate School of Public Policy. Recently, he has completed an Institute of Corporate Directors designation.

In 2012, Chief Delorme received the Queen Elizabeth II Diamond Jubilee Medal, recognizing his student leadership and the hospitality he showed to Prince Charles and his wife Camilla, Duchess of Cornwall, when they visited FNUniv. He was also named one of CBC Saskatchewan's Future 40, which celebrates the province's new generation of leaders, builders and change-makers under the age of 40.

In 2019, Chief Delorme was re-elected to a second term in office. Under his leadership, Cowessess First Nation has focused on economic self-sustainability for its nation and people and has moved forward on renewable energy, agriculture, efficiency in land use initiatives that have created both current and future business opportunities.

This past year, Chief Delorme faced one of the hardest moments as Chief when the Saulteaux and Cree First

Nation made international headlines with the discovery of potentially 751 unmarked graves near the former Marieval Indian Residential School. Shortly after, Cowessess made headlines again as the first First Nations community to sign an agreement with Ottawa that returns jurisdiction over children in care to the community. Federal legislation overhauling Indigenous child welfare was passed in 2019 and came into force last year.

Dr. Leyton Schnellert

Creating and Nurturing Collaborative, Inquiry-Based Professional Learning for Teachers *November 1, 2022*

Dr. Leyton Schnellert is an Associate Professor in UBC's Department of Curriculum & Pedagogy and Eleanor Rix Professor of Rural Teacher Education. His scholarship attends to **how teachers and teaching and learners and learning can mindfully embrace student diversity and inclusive education.** Dr. Schnellert is the Pedagogy and Participation research cluster lead in UBC's Institute for Community Engaged Research (ICER) and co-chair of BC's Rural Education Advisory. His community-based collaborative work contributes a counterargument to topdown approaches that operate from deficit models, instead drawing from communities' funds of knowledge to build participatory, place-conscious, and culturally responsive practices. Dr. Schnellert has been a middle and secondary school classroom teacher and a learning resource teacher K-12. His books, films, and research articles are widely referenced in local, national, and international contexts.

Carole Fullerton

Number Sense In Elementary: Seeing the Math in Action January 31, 2023

Carole Fullerton is passionate about mathematics instruction. Carole is a teacher-leader working in K-12 classrooms to support the development of numeracy instruction across BC, Alberta, Manitoba, Yukon, the Northwest Territories and beyond. Addressing student diversity through rich questions, teaching through problem-solving and planning around the Big Math Ideas are essential aspects of her practice. In her collaborative work, she strives to engage students and their teachers in thoughtful investigations of what it means to DO math, learning through exploration, talk and play.

Reassessing Assessment Practices in Mathematics April 27, 2023

Dave Martin has a Masters of Mathematics, a Degree in Education, and has a love for prime numbers. He has been teaching for 12 years, during which time, he was nominated for Teacher of Excellence in Alberta, has spoken across North America, and has successfully removed grades in most of his high school math courses. Dave has taught grades 6 - 12, was one of the division's Math/Science Lead teachers, and is now currently a Vice-Principal of a K-9 school.
