The First Page student writing challenge is coming back!

The First Page is a national writing competition for Grades 7 to 12 students in Canada. Students are invited to write the first page of a novel, imagining how present-day issues and trends have played out 150 years in the future.

The 2024 challenge will be open for submissions starting in **February 2024**. At the beginning of 2024, we'll announce the official entry period and who will be the judge and readers for this year's competition. Past judges include New York Times bestselling author Courtney Summers, Sarah Raughley, author of the YA Effigies series, and Governor General's Literary Award-winning author David A. Robertson.

How will the world leaders of today impact the world of tomorrow? Who will be the biggest name in pop culture in the future? How will climate change impact the protagonist's life?

The story could be from any literary genre, from mystery or thriller to literary fiction, from adventure or romance to satire or science fiction.

Last year's winners were Christian A. Yiouroukis for his story <u>Where the Maple Leaf Grows</u> and Bee Lang for their story <u>One Question</u>.

**WHAT YOU CAN WRITE:** Your entry can be 300-400 words in length. Your entry also needs a title, but the title is not included in the word limit. Your entry can be written in any genre.

**WHO CAN ENTER:** This contest is open to all Canadian residents who are full-time students enrolled in Grades 7 to 12. Entries will be judged in two age categories: Grades 7 to 9 and Grades 10 to 12.

**PRIZES:** The winner of each category will receive a one-year subscription to <u>OwlCrate</u>, which delivers monthly boxes of books and literary-related goodies. The school library of each winner will also receive a donation of 50 books.

**HOW TO SUBMIT:** During the submission period, a link to an online entry form will be available on this page. We'll share more details about when and how to submit in early 2024.

As you can see from the attached poster, 13 Manitoba post-secondary institutions are setting up tables at the Fair, so that students already studying at Manitoba K-12 school divisions, independent schools, and language schools can come to network with these international recruiters from Manitoba. Exposure to what Manitoba post-secondary institutions have to offer can help students consider staying in Manitoba for their post-secondary education and perhaps eventually for the long term.

**NOTE**: Although the Fair is being targeted at <u>international</u> high school students, it is also applicable to students who are currently <u>children of parents with study or work permits</u>, who will not continue to be considered domestic students once they turn 19 and then move on to post-secondary studies.

Renée Cable, Minister of Advanced Education, Skills and Immigration and Nello Altomare, Minister of Education and Early Childhood Learning will bring greetings, and extol the advantages of staying in Manitoba to study at the world-class post-secondary institutions in our province. Following the opening program in the Muriel Richardson Auditorium, the Ministers and the students will move into Eckhardt Hall to browse the recruitment tables.

This will be a **fun fair with snacks and prizes**, and following the Fair, MCIE has arranged for **students under 18 to visit the galleries at the WAG for FREE!** So the Fair can also be combined with a 'cultural experience' for your students!
