Vimy Inspires Tomorrow (VIT) is a history-based leadership program for youth in Canada, ages 13-17. This <u>program</u> encourages students to draw on lessons from history to examine, discuss, and exercise key



leadership skills, all of which can be applied to their daily lives as young leaders in their communities.

Youth can submit an idea for a project that benefits their community to be eligible for leadership training and a \$2,500 project grant. The deadline for applications is December 11, 2023.
