THAT By-Law No. 138, being a by-law of the Trustees of the Pembina Trails School Division in Manitoba, providing for the borrowing of moneys upon the credit of the said School Division to meet current expenses for the Fiscal Year 2020-21, be given second and third reading and passed.

### MANITOBA SCHOOL DIVISION/DISTRICT BORROWING BY-LAW BY-LAW NO. 138

A By-Law of the Trustees of The Pembina Trails School Division in Manitoba, providing for the borrowing of moneys upon the credit of the said School Division to meet current expenses for the Fiscal Year 2020-2021.

WHEREAS the estimate of the School Division, as prepared by the Trustees thereof, of the amount required to meet the expenditures for such School Division for the year 2020-2021 is the sum of \$180,702,477 (Operating and Capital Budget).

AND WHEREAS no moneys have been previously borrowed to meet the expenditures of the year 2020-2021,

NOW THEREFORE the Trustees of The Pembina Trails School Division in session enact as follows:

- 1) THAT, pursuant to Section 221 of *The Public Schools Act*, the amount of the borrowing as set out in this By-Law shall not cause the Pembina Trails School Division at any time to exceed either (a) or (b) which ever is applicable:
  - (a) the amount of the estimate of the approved expenses of the School Division for the current year; or
  - (b) the amount of the estimate of the approved expenses of the School Division for the last preceding year, such estimate of approved expenses for the current year not yet having been calculated.
- 2) THAT the Trustees of the said School Division do borrow up to the sum of Forty-Five Million Fifty Thousand dollars (\$45,550,000) from TORONTO DOMINION BANK upon the credit of the said School Division, and as set out under the terms of the Demand Operating Facility Agreement with TORONTO DOMINION BANK, October 21, 2008, and do pay or agree to pay interest thereon either in advance or at maturity, at the rate of the Bank's Prime Interest Rate minus 0.75% (per centum) per annum or Banker's Acceptance plus 0.25%.
- 3) THAT the said borrowing may be by means of an overdraft on the account of the School Division via prime rate based loan or via Banker's Acceptance as per the Demand Operating Facility Agreement, by cheques signed by the Chair of Finance & Planning Committee and the Secretary-Treasurer or Assistant Secretary-Treasurer,
- 4) THAT the amount so borrowed shall be a first charge upon any moneys to be received by the Trustees on account of the estimate for the 2020-2021 Fiscal Year for the purposes of the said School Division, whether from the Municipality or from the Provincial Government or from any other source and, as the same are received, the said School Division shall deposit them with the said Bank in a special account as collateral security for payment of the amount so borrowed with interest thereon, but the said Bank shall not be restricted thereto for the payment of the sum or sums so borrowed, nor shall it be bound to wait for repayment of the moneys so borrowed until the Municipality or the Provincial Government has discharged its obligation to the School Division nor be obliged to see that moneys paid to the School Division are deposited or applied as aforesaid,
- 5) THAT this By-Law shall extend to and cover borrowings by the said Trustees for the year commencing the first day of July, 2020, and to the extent necessary, this By-Law shall have retroactive effect so as to be deemed in full force and effect at the commencement of said term,
- 6) THAT nothing herein contained shall waive, prejudicially affect or exclude any right, power, benefit or security by statute, common law or otherwise given to or implied in favour of the said Bank,
- 7) PRIME Interest Rate is the annual rate of interest announced from time to time by TORONTO DOMINION BANK as a reference rate then in effect for determining interest rates on Canadian dollar commercial loans in Canada.

### **Pembina Trails School Division**

### By-law No. 139

Being a by-law of the Board of Trustees of Pembina Trails School Division for the purpose of borrowing the sum of Three Million Nine Hundred Fifty Four Thousand One Hundred Dollars (\$3,954,100) and of issuing a Debenture and/or Promissory Note (hereinafter called the Security) therefore.

WHEREAS it is deemed necessary and expedient to raise by loan the sum of \$3,954,100 on the credit of the said School Division for the purpose of payment for the projects as authorized on Schedule "B" attached.

THEREFORE, pursuant to the provisions of the Public Schools Act, the Board of Trustees of the Pembina Trails School Division duly assembled, enact as follows:

- 1. That it shall be lawful for the said School Trustees to borrow the sum of \$3,954,100 by the issue and sale of the Security of the said School Division as set out below.
- 2. That the said Security shall be issued at Winnipeg MB and shall be dated the 15th day of May A.D. 2020 and shall be payable to the Minister of Finance, Winnipeg, Manitoba as follows:

  The Security shall be so issued that the amount thereby borrowed shall be repayable in twenty (20) equalized consecutive annual instalments of \$265,777.63 each, including principal and interest at the rate of 3.000% per annum, payable annually on the 15th day of May as per Schedule "A" attached.
- 3. That the first instalment shall be payable on the 15th day of May A.D. 2021
- 4. That the Security shall be signed by the Secretary-Treasurer and countersigned by one of the Trustee of the said School Division.
- 5. That provisions shall be made for the payment of the said Security and such provision shall form part of, and be included in, the annual statements of monies required for the purpose of the School Division.

### COVID-19 **INFORMATION**

For many weeks now, the news cycle has been dominated (and rightfully so) by information about the COVID-19 pandemic. We don't want to add to the noise, but we did want to provide links to the most relevant sites in one spot, for ease of access.

For general information specific to Manitoba, visit the Manitoba government's dedicated COVID-19 page. Here you will find helpful tools such as Shared Health's online screening tool, which helps people determine whether they should be reaching out to a health care professional at Health Links-Info Santé. There is also a link to Help Next Door Manitoba, a site dedicated to linking Manitobans who need help with those able to assist them. The page will also link you to all government news releases on COVID-19, while livestreamed and archived news conferences can be found on the government's YouTube channel.

Provincial statistical updates can be found in the regular COVID-19 bulletins, while the Public Health Agency of Canada site includes information about the current situation nationally. The PHAC site also includes information about prevention and risks, symptoms and treatment, and travel advice. All sites are updated on an ongoing basis.

### IN-CLASS LEARNING SUSPENDED

On March 31, on the advice of the chief provincial health officer, the government announced the indefinite suspension of all classroom learning for K-12 students in the province. Full details of the closure are included in the government news release. This action has been taken to help flatten the curve and reduce the impact of COVID-19 throughout the province. With the suspension of classroom learning:

- all students on track to graduate will do so.
- teachers will teach remotely, assign work, conduct assessments and prepare final report cards.
- provincial exams will be cancelled for students in grade 12, but teacher assessments will be implemented.
- provincial assessments are complete for students in early and middle years, but other assessments will continue.
- child-care centres located in schools will continue to operate under the current conditions set out by the chief provincial public health officer.

### REPORT SCHOOL VANDALISM

With fewer people in the vicinity of schools as a result of the indefinite suspension of in-class instruction, the possibility of acts of vandalism targeting those buildings is increased. For that reason, our usual summer stop school vandalism program is being activated in early April. To report suspicious activity on school grounds between the hours of 10:00 p.m. and 7:00 a.m., or to report an act of school vandalism in Winnipeg, call 204-231-4556. This program will continue into the summer, unless the public health order is suspended before then and schools return to normal operations.
