#### November 22: Trustee Professional Development

This day will consist of two plenary sessions, two banks of concurrent workshops (with a minimum of three offerings per bank), and an update on the status of and issues facing school boards across Canada. A preliminary list of workshop topics is provided in the attached program; this will be augmented in the coming weeks, and a full list with descriptions will be distributed in late October. No pre-selection of sessions is required; delegates will be able to choose which session(s) to attend on-site.

A \$125 registration fee will apply to the November 22 sessions.

#### **November 23: Association General Meeting and Regional Meetings**

There will be three main components to the November 23 session, as follows:

- a general session for all trustees dedicated to association business, including an update on the work of the
  association, a financial report, introduction of executive resolutions (to be voted on in March), and nominations
  for positions to be elected in March;
- regional meetings (breakouts), for the presentation and discussion of regional resolutions, MUST Fund elections (where terms are expiring or vacancies otherwise exist), and discussion of regional issues; and
- a general session for information sharing and discussion of provincial issues.

There is no cost to attend on November 23, although pre-registration is required to enable us to make the necessary arrangements for meeting space and meals.

Planning is already well underway for the 2020 CSBA Congress and National Trustee Gathering on Indigenous Education, July 2 to 5 in Banff, Alberta. The theme for this event will be Standing Stronger Together. Confirmed speakers include Lieutenant-General The Honourable Roméo Dallaire and educational change and leadership expert Andy Hargreaves. The Alberta School Boards Association, host organization of the 2020 event, is currently seeking session proposals for the Congress and Gathering. Specific areas of interest

Standing Stronger Together educational governance and leadership, and connecting research, policy and practice. The deadline for receipt of proposals is October 11.

#### **ACCESSIBILITY STANDARDS UPDATE**

The development of standards under *The Accessibility for* Manitobans Act is continuing, with the final two standards currently under discussion and review by the Accessibility Advisory Council. The Council has posted its draft accessibility standards on <u>Information and Communication</u>, and held a public forum on the scope and intent of the accessibility standard for the design of public spaces. Information about the legislation and already-adopted standards may be accessed through the Accessibility Manitoba website. We'll keep you advised of further developments as they are known.

#### **BREAK THE FAKE!**

It can be tough to tell what's true and what's "fake news" just by looking at a headline, but it's easy to do a quick check and get the real facts when something doesn't



look right online. That's the premise behind this year's Media Literacy Week (October 7 to 11), sponsored by Media Smarts. The goal is to help Canadians (and especially young people) Break the Fake by stopping the spread of false information and getting people to check before sharing. To help in this regard, Media Smarts has developed Break the Fake resources, including fact-checking tip sheets and <u>lesson plans</u> for educators.

#### NATIONAL CENTRE FOR COLLABORATION IN INDIGENOUS EDUCATION

With Orange Shirt Day just around the corner, now would be a great time to check out the National Centre for Collaboration in Indigenous Education website. The Centre is hosted by First Nations University of Canada. It is grounded in principles of respect, reciprocity, and relationship, which are understood in Indigenous ways and honoured according to Indigenous protocols and customs. In accordance with its mission, the Centre highlights innovative and exciting examples of Indigenous education from across the country and facilitates collaborative networking. The website includes materials on Indigenous languages (including audio), a resource library, a section dedicated to reconciliation, and more.



#### HISTORIC SUPREME COURT VISIT AN IMPORTANT REMINDER OF SCHOOL BOARD ROLES

For the first time in nearly a century and a half, the Supreme Court of Canada convened the second of two appeals outside of Ottawa today, which serves as the regular seat for the highest judicial authority in Canada.

"On behalf of Manitoba's school boards, we welcome the Supreme Court Justices to Winnipeg," said Alan M. Campbell, president of the Manitoba School Boards Association. "The Court's presence here serves as an important reminder of the importance of protecting several core Canadian values, including democracy, the division of powers, the rule of law and protection of minority rights."

In no other instance has the Supreme Court's decision-making role been as important than in cases pertaining to community rights in respect of education. It is therefore fitting that today's appeal, in the case of Conseil scolaire francophone de la Colombie-Britannique v. British Columbia (B.C.) is being heard in Manitoba, the flashpoint for several landmark decisions concerning minority francophone rights by the Supreme Court of Canada, and where community rights to ownership and control of local education remain critical to student success.

"It is indeed noteworthy that one school board in particular in our province, la Division scolaire franco-manitobaine, was established as a direct result of the Supreme Court's interpretation of minority language community rights concerning the future of their children," continued president Campbell. "In the landmark 1993 reference to the Court by the Province of Manitoba, the Justices found that community rights to control the education of their children remained paramount, from classrooms, to playgrounds to the very posters on the wall."

The Court's findings in Reference re: Public Schools Act (Man.), s. 79(3), (4) and (7), [1993] 1 SCR 839 provided for the establishment of a school board chosen by members of Manitoba's francophone minority community in recognition that local voices and local choices are best positioned to provide the programs, supports and services that will meet the needs of students and communities. The Manitoba Government later amended *The Public Schools Act* to provide for such a school board in the form of the Commission scolaire franco-manitobaine.

At issue in the current appeal being heard in Winnipeg: under Conseil scolaire francophone de la Colombie-Britannique v. British Columbia (B.C.) is provincial support for services as required to sustain a vibrant minority language program for francophone students.

"School boards across Canada are watching today's case very closely," stated president Campbell. "An important reality of local choices being made for the benefit of students, whether in minority language contexts or majority language contexts, focuses on the availability of resources to ensure all students' needs are met."

"As always, such cases reflect much more than questions of French or English rights in education. Decisions made by the Supreme Court touch upon the essence of every community's right to provide quality education for the continuing advantage of every citizen."

In Canada, school board governance reflects a long held democratic heritage dating back to before Confederation in 1867. Being situated close to the same communities where matters of local education are decided, trustees have worked in partnership with provincial governments to ensure that our nation's public schools are ranked as the leading education system in the English speaking world. This includes the important contributions made to achieving this standing by every province, including Manitoba, and by both English and French schools.

"In Manitoba, close cooperation between the provincial government and local school boards have ensured that our public schools remain among the world's best," concluded president Campbell. "Going forward, it is important to recognize that this division of power between a strong central government and local communities remains fundamental to the protection of this important standing."

Statement from CSBA President in response to Quebec Government's Intent to Abolish French Governing School Boards

The Canadian School Boards Association (CSBA) and the members and communities we represent across the country are shocked and saddened to hear the Quebec provincial government's interest in robbing their French-speaking citizens of a public education system governed by democratically elected community members dedicated to public education.

The democratic practice of electing representation to serve the needs of citizens is a cornerstone of Canadian society, and this applies to representation supporting public education. Governing school boards are members of the communities they serve, dedicated to the public education system, and providing access and transparency to local decisions. The solution to concerns with a democratic system is to improve it, not to eliminate it.

If the provincial government of Quebec has such concerns with governing school boards, we call on them to work **WITH** the provincial school board associations to strengthen these roles in service of students to whom they are accountable. Recent research strongly supported that "high functioning governing school boards support student success and quality public education", found here <a href="http://www.cdnsba.org/wp-content/uploads/2019/09/Elected-School-Boards-Literature-Review-FINAL.pdf">http://www.cdnsba.org/wp-content/uploads/2019/09/Elected-School-Boards-Literature-Review-FINAL.pdf</a>. Governments would be wise to strengthen this partnership.

The government should also consider the election process for governing school boards if voter turnout is a concern. Low voter turnout is a problem that touches all levels of government. In other jurisdictions across Canada, school board elections are tied with municipal elections to support voter turnout, reduce duplication of costs and improve accessibility. Quebec should consider following a similar approach.

All people of Quebec have a right to democratically elected governing school boards in their public education systems, regardless if schooling is in French or English. We have seen the loss of majority English governing school boards in Nova Scotia and the negative effect this is having on the education community. Parents, guardians, students and education staff have spoken out that they no longer have access to policy and decision makers. This elimination of community voice has not improved public education. Having community members govern public education is vital for both majority and minority communities.

Public education deserves community representation via all governing school boards who have the autonomy to make the best decisions for their students. We urge the Minister to reconsider this legislation and work with school boards to strengthen student success for all citizens, for now and future generations.

Déclaration de la présidente de l'ACCCS suite à l'intention du gouvernement du Québec d'abolir les commissions scolaires francophones

L'Association canadienne des commissions/conseils scolaires (ACCCS) ainsi que les membres et les communautés que nous représentons d'un océan à l'autre du pays sont choqués et attristés par l'intention du gouvernement provincial du Québec de priver ses citoyens d'expression française d'un système d'éducation publique gouverné par des membres de la communauté élus démocratiquement qui ont l'enseignement public à cœur.

La pratique démocratique qui consiste à élire une représentation pour répondre aux besoins des citoyens est une pierre angulaire de la société canadienne et cela s'applique à la représentation qui appuie l'enseignement public. Les commissions scolaires sont des membres des communautés qu'elles desservent, se consacrent au système d'éducation publique et assurent l'accès aux décisions locales ainsi que leur transparence. La solution aux préoccupations liées à un système démocratique est de l'améliorer et non de l'éliminer.

Si le gouvernement provincial du Québec a de telles préoccupations concernant les commissions scolaires, nous lui demandons de travailler **AVEC** les associations provinciales de commissions scolaires afin de renforcer ces rôles au service des élèves devant lesquels elles sont responsables. Des recherches récentes ont appuyé sans équivoque la conclusion que « les commissions et les conseils scolaires très performants

favorisent la réussite des élèves et l'enseignement public de qualité » (vous référer au <a href="http://www.cdnsba.org/wp-content/uploads/2019/09/Elected-School-Boards-Literature-Review-FINAL.pdf">http://www.cdnsba.org/wp-content/uploads/2019/09/Elected-School-Boards-Literature-Review-FINAL.pdf</a>). Les gouvernements auraient intérêt à renforcer ce partenariat. Par ailleurs, le gouvernement devrait évaluer le processus électoral des commissions scolaires si la participation électorale est inquiétante. La faible participation électorale est un problème qui touche tous les niveaux de gouvernement. Dans d'autres régions à l'échelle du Canada, les élections des commissions scolaires sont jumelées aux élections municipales pour favoriser la participation électorale, réduire la duplication des coûts et améliorer l'accessibilité. Le Québec devrait envisager d'adopter une approche semblable.

L'ensemble de la population québécoise a droit à des commissions scolaires élues démocratiquement dans ses systèmes d'éducation publique, que l'enseignement soit en français ou en anglais. Nous avons été témoins de la perte des conseils scolaires de la majorité anglophone en Nouvelle-Écosse et des conséquences négatives qui en ont découlé pour la collectivité éducative. Les parents, tuteurs, élèves et membres du personnel d'éducation se sont levés pour dire qu'ils n'ont plus accès aux décideurs politiques. Cette élimination de la voix communautaire n'a pas amélioré l'enseignement public. La gouvernance de l'enseignement public par des membres de la collectivité est essentielle à la fois pour les communautés majoritaires et minoritaires.



#### RE: PROPOSED DISSOLUTION OF THE AAEM

Dear AAEM Member,

This letter is to bring you up to date on the current state of affairs within the AAEM, and to let you know that at a recent meeting of our board, we voted to pursue dissolution of the organization, including the forwarding of a motion to do so at our forthcoming AGM this October 2nd, 2019.

As you likely know, the AAEM began as an ad hoc committee struck under the leadership of the Manitoba Arts Council (MAC) in 2001. Subsequently, the AAEM became incorporated as a non-profit organization and has been

administered by a series of dedicated volunteer boards ever since. Throughout its existence, the AAEM has received critical financial support from MAC through annual grants. While we have also consistently sought to diversify our funding sources, receiving important supplementary support from the Winnipeg Foundation and Francofonds Inc., for example, as well as membership fees and conference registrations, MAC's support has been foundational. MAC has enabled us to undertake a wide range of annual projects and engage our administrative assistant and independent coordinator, Sylvie Cottee. Without MAC's support, it would have been impossible for our organization to achieve all that it has, and for that we are all very grateful. Unfortunately, however, under MAC's new granting guidelines, the AAEM as an organization involved in arts education and advocacy, no longer qualifies under any of their funding categories.

While the loss of our primary source of organizational funding would, in and of itself, provide grounds for questioning our viability, there are other circumstances as well that are part of the present discussion. For example, a recent AAEM grant application to the Winnipeg Foundation, in which we sought project funding for an initiative to coordinate a culturally inclusive line-up of student art and performance as part of the upcoming Canadian Network for Arts and Learning (CNAL) Conference this October was also unsuccessful. The Winnipeg Foundation had approved a significantly larger grant directly to the CNAL for this event, and that may well have factored into their decision. Nonetheless, this has left us even more fiscally hamstrung for the immediate term. Moreover, in combination with our loss of MAC support for not only this year, but presumably years to come, we felt compelled to consider dissolution.

There are further, and indeed more positive considerations as well that are part of our thinking. These concern our record of achievement, and the fact that some of the original goals of our organization have been met. The AAEM was established out of a need to advocate for arts curriculum renewal in our province, and to provide a forum for stakeholders in the arts to advocate for the place of the arts and education in our schools. In 2001, professional associations existed exclusively for Music and Visual Arts educators, and the original alliance brought those groups together (an achievement in itself) along with, for the first time in Manitoba, leaders in drama and dance education around the shared mission of speaking with a united voice and calling for more and better arts education for Manitobans. Over the course of the following two

decades, and thanks in large part to the advocacy efforts of the AAEM, Manitoba Education established an arts curriculum renewal process and created two permanent arts consultant positions to oversee the creation of what are now the official K-12 Curriculum Frameworks in Dance, Drama, Music and Visual Arts for Manitoba schools. As well, professional associations in Dance and Drama now exist alongside those in Music and Visual Arts as official MTS Special Area Groups in Education (SAGE), ensuring that ongoing advocacy and professional learning opportunities across the arts in Manitoba are and will continue to be in place.

While we believe that new curricula and new professional arts-teaching associations have strengthened arts education in Manitoba, we have also continued to identify other areas where we believe that action to support and improve arts education is warranted. For example, our "ArtSpark" events have highlighted youth achievement in the arts and provided forums for hundreds of student artists to share ideas about the value of the arts in their learning, and our "Building Bridges" think-tanks have assembled arts educators, students, representatives of community arts groups, and indigenous artists, speakers and student performers to explore the challenges of reconciliation following the publication of Truth and Reconciliation Commission's *Calls to Action*.

The AAEM has always highlighted the ideas, works and performances of children and youth as the most powerful form of advocacy for arts education. Given our imminent dissolution, we will trust that the presence of quality arts education in Manitoba schools and communities will continue to support the development of inspiring young artists as a critical source of advocacy. We can promise that as individuals, our current board members will continue to hold on to the values of the AAEM and seek ways to speak out and work in support of the arts in education when opportunities arise, and we hope that you will do the same.
