**The upcoming election** is an opportunity for voters to shape the future of our province. The next government will be making critical decisions in areas that affect the daily lives of Manitobans: healthcare, roads and infrastructure, crime reduction strategies, economic development, and education.

All of these issues are important, but none more so than education. The impact of education on other determinants of well-being is well understood. Educated populations are healthier, and less likely to become involved in the criminal justice system. Good schools are far less expensive to operate than jails. Education is critical to building a skilled workforce, and a skilled workforce not only provides the solid tax base we need for social services, but is also less reliant on those same services.

Supporting education is an investment in our future that benefits everyone. This election is our opportunity to let candidates know that we value education, and to support those that share this value.

#### Why education now?

Education is always an important election issue, but 2019 is a watershed year in Manitoba. In January, the government launched a Commission to review K-12 education. Thousands of Manitobans shared their thoughts, through online surveys, written submissions, and public consultations. Formal consultations concluded in June, and the Commission will spend the next several months preparing its report and recommendations. Those will be made public in March 2020, and the government we elect in September will decide what actions to take.



The Commission's areas of focus—vision, learning and teaching, accountability, governance, and funding—clearly outline what's under consideration. What do you see as the current strengths, challenges and opportunities in these aspects of our public school system, and what would you like to see changed or preserved in our K-12 system?

#### Helping all students learn

Public schools welcome all children and youth through their doors, resulting in a diverse student population. That diversity is one of the strengths of public education, but if schools are to fulfill their core mandate of ensuring that all students achieve at a high level, additional supports are sometimes required. Whether it's specialized language instruction for newcomers, occupational or physical therapy for a child with special needs, or clinical intervention for one in crisis, these students must be supported. In our public schools, one size does not fit all.



Are you aware of the diversity that exists in Manitoba's public school population? What would you do to ensure that schools have the resources they need to support every student so they can thrive and achieve at a high level?

#### Beyond school walls

Health and education have a symbiotic relationship. Just as education tends to improve health, good health is one of the determinants of positive educational outcomes, and children living in poverty too often shoulder the consequences of both diminished health and lower educational outcomes. Schools work to mitigate the negative effects of poverty on their students' learning and health through initiatives such as meal programs, pre-school outreach to families, and summer enrichment programs, but schools cannot tackle the challenge of poverty alone. It will take a concerted effort by all levels of government, as well as other public and private institutions, to not only address the effects of poverty, but also its underlying causes.



Do you support the efforts of schools in your community to help students overcome the negative effects of poverty on their health and education? What is your understanding of the relative responsibility of schools, municipalities, and the provincial government in supporting students and families in poverty? Are there specific provincial initiatives you support that would help in this regard?

#### **Preserving local voice**

All Manitoba public schools provide a solid core education based on the provincially mandated curriculum, but not all schools are the same. Some offer programming that helps preserve community heritage for future generations, such as language courses. Pre-school programming helps ensure that students are ready to learn when they enter kindergarten, but that programming takes many different forms across the province. At the other end of K-12 spectrum, school divisions partner with local businesses, post-secondary institutions, and neighbouring divisions to develop technical and vocational programming that helps youth transition to the workforce and communities grow and prosper. Programs such as these are made possible because of funds raised by the special levy, the property tax set by school boards to support education.



Are you familiar with the types of locally-supported programming that exists in schools in your community? How would you work to ensure that communities retain the ability to shape schools to meet their specific needs and wishes?

#### The value of school boards

Manitoba has 37 elected school boards, comprised of almost 300 school trustees. School trustees are not full-time employees with benefits; they are community representatives, working for minimal compensation to govern local schools. Provincially, the cost of school boards amounts to 0.5% of the provincial education operating budget. An additional 3% pays for the highly qualified administrators needed to manage and lead educators and other staff in the complex business of education. Combined, board and administration costs total 3.5% of operating budgets, an amount that is capped by law and which compares favourably to other levels of government. This means that more than 95% of education dollars are spent in classrooms, paying for operations and maintenance, and transporting students.

Some argue that Manitoba has too many school divisions, simply because other provinces may have fewer. But reducing school divisions does not reduce costs, as was shown when mandated amalgamations reduced the number from 54 to 37 in 2001. What it does do is increase costs, create a great deal of disruption and uncertainty in the system, and dilute community voice. If we are going to reduce the number of school divisions in Manitoba, we need to do so for a better reason than "because everyone else is doing it"—and objectively, that reason does not exist.



Do you know what school boards actually do in Manitoba? Do you believe that they add value to our public school system? Are you willing to work cooperatively with school boards in your community to the benefit of local students and schools? Do you support the current configuration of school divisions in Manitoba, and if not, how do you think it should be changed?

#### CSBA selects President and Vice President at AGM

July 8, 2019, Toronto, ON: At the 2019 Canadian School Boards Association Annual General Meeting, held as part of the annual congress, Laurie French was selected as President for the 2019-2020 year. This will be her second term as President of the CSBA. Ms. French is the Past-President of the Ontario Public School Boards Association and Vice-Chair of the Limestone District School Board for Greater Napanee in her sixth Term as Trustee.

Alain Fortier, President of the Fédération des commissions scolaires du Québec and Chair of the Commission scolaire des découvreurs will serve as Vice-President. This will be Mr. Fortier's first term in this role, having completed previous terms as a member of the Board of Directors. Together with the Executive Director, the President and Vice-President will provide strong leadership as executive for the CSBA.

"I am honoured and pleased to return for another year as President of the Canadian School Boards Association," said Ms. French. #### Manitoba School Boards Association Negotiating Receipt of Federal Climate Funds

The Manitoba School Boards Association is working collaboratively with the Federal Government to ensure that Manitoba schools receive a share of Climate Action Incentive Funds in the 2019/20 Fiscal Year. If negotiations are successful, federal carbon pricing revenues will be available to Manitoba schools for investment in an array of school-based energy efficiency initiatives.

"The Manitoba School Boards Association is well positioned to coordinate receipt and payment of these funds to our school board members," said Alan M. Campbell, association president.

Over many years, Manitoba schools have benefited greatly from several investments, mostly from the provincial government, in sustainable infrastructure and clean energy to minimize the carbon footprint of schools and thereby reduce any pollution arising from school operations.

All new school buildings are constructed by the Government of Manitoba using a minimum LEED Silver designation, meaning that school boards continue to benefit from significant provincial investments that remain the primary foundation for promoting capital sustainability across public education infrastructure in Manitoba. The federal Climate Action Incentive Fund will add to this strategy with nearly \$5.4 million in funding towards ongoing objectives of promoting energy efficiency and green environment capital retrofits.

"Today's statement by the federal government signals an important added investment towards promoting the sustainability of our schools," said president Campbell. "We welcome the federal government's decision to work with our association, as a non-profit and neutral third party, to ensure that the carbon pricing funds that have been collected from school boards, are returned to school boards."

Today's decision means that Manitoba school boards will join their counterparts in Ontario, Saskatchewan and New Brunswick, in receiving the first carbon pricing backstop funding arising from the newly implemented federal carbon pricing.

While the funds will not result in new capital infrastructure in Manitoba, the ability to direct the funds to significant energy efficiency retrofits for existing capital assets, such as new windows, better lighting, new furnaces, smart thermostats and controls and renewable energy, will help schools to continue to reduce their carbon footprint and achieve energy savings.

"In good faith, we are hopeful that we will be able to deliver these funds on behalf of Manitoba's school boards, schools and students," concluded president Campbell. "We are pleased that the federal government has identified our association as a potential partner, and will work to flow these funds to schools in Manitoba."

## Fall Principals campaign 2019-20 Cover note to principals

#### Dear School Principal,

Copyright rules for educators have changed significantly in recent years. While teachers have new opportunities to use copyright-protected materials in their lessons, they also have responsibilities. There are limits to what can be copied and communicated in the classroom. Teachers must know what they can and cannot do with the copyright-protected works of others. Failure to comply with copyright law can result in a teacher, school, or school board being sued for copyright infringement. The fair dealing provision in Canada's copyright law permits teachers to copy and communicate short excerpts from copyright-protected works provided the dealing is "fair."

Ministries/departments of education across Canada with responsibility for elementary-secondary education (with the exception of Quebec) strive to ensure that teachers have the latest information about fair dealing. The Copyright Consortium of the Council of Ministers of Education, Canada has developed a Web site to assist teachers in complying with the copyright law: <a href="www.fairdealingdecisiontool.ca">www.fairdealingdecisiontool.ca</a>. This Web site features a fair dealing decision tool that enables teachers to quickly determine whether they can use specific materials in their lessons. This Web site also provides an overview of the Fair Dealing Guidelines, along with posters to remind teachers about the guidelines as well as the restrictions on copying consumables, such as workbooks and materials meant for one-time use.

#### Principals are asked to:

- 1. mention this Web site at a staff meeting and to encourage all teachers to visit the site and view the related materials.
- 2. ensure both the attached *Fair Dealing Guidelines* and Consumables posters are placed near photocopiers and printers.
- 3. post the attached notice regarding available copyright reference resources in the staff room and/or main office.

### Suggested speaking points for principal

#### Copyright and the Use of Fair Dealing in the Classroom

#### Introducing the subject

• This is a brief, 10-minute presentation on fair dealing – a provision in the *Copyright Act* that is very important for teachers to understand. Performing typical duties, such as preparing lessons for classroom use, could result in costly lawsuits against individual teachers, this school, and the school board.

#### Changes to copyright

- Canada's copyright law includes a fair-dealing provision that permits teachers to use short excerpts from copyright-protected works in their class lessons.
- While fair dealing provides teachers with opportunities to use copyright-protected materials in their lessons without needing to obtain permission from the copyright owner, teachers also have important responsibilities.
- Teachers need to know the limits to what can be copied and communicated in the classroom under fair dealing.
- Teachers' limits and responsibilities are described in the Fair Dealing Guidelines.
- Failure to know and respect the *Fair Dealing Guidelines* could result in a teacher, school, or school board being sued for copyright infringement.

#### Fair dealing Web site

- The Copyright Consortium of the Council of Ministers of Education, Canada has developed a
  Web site that features a fair dealing decision tool that enables teachers to quickly
  determine whether a specific use of a copyright-protected work is permitted without
  needing permission from the copyright owner. If the dealing is fair, copyright permission is
  not required. This Web site also provides essential information on the Fair Dealing
  Guidelines and other important copyright information.
- SHOW WEB SITE www.FairDealingDecisionTool.ca
   (Suggestion: Click through one example such as a teacher wanting to copy a single chapter from a book.)
- ASK TEACHERS TO BOOKMARK THE WEB SITE AND START USING IT.

#### Fair dealing posters

- Following the *Fair Dealing Guidelines* is important. Teachers can copy and use materials which fall within the guidelines without permission from the copyright owner.
- Teachers should never reproduce "consumables," such as student workbooks and other materials intended to be used once.
- SHOW 2 POSTERS the Fair Dealing Guidelines and Consumables posters (electronic files attached.)

• These posters are to be placed at copy machines around the school to reference the *Fair Dealing Guidelines* and as a reminder that copying consumables is prohibited. Both should be familiar to all teachers.

#### Conclusion

- Why are we taking the time to talk about copyright today? It is important for teachers to know what they can and cannot do under fair dealing. Teachers must know and respect the limits in the Fair Dealing Guidelines.

# WARNING DO NOT COPY CONSUMABLES

Consumables are materials intended for one-time use such as workbooks and exercise sheets in which a student records answers. These are materials created and intended for each student to have his or her own copy. Once a student completes the answers, these materials are of no use to another student.

Unless you have permission to copy a consumable, copying, scanning, or printing materials intended for one-time use is strictly prohibited.

Any copying from materials intended for one-time use without permission exposes the person making the copy, the teacher, the school, and the school board to liability for copyright infringement.

This prohibition does not apply to reproducibles. A reproducible is not intended for one-time use, but is sold or provided with the rights holder's authorization to reproduce it for educational use.

This prohibition does not apply if you have permission to copy a consumable or created the consumable yourself.





# Fair Dealing

The fair dealing provision in the *Copyright Act* permits use of a copyright-protected work without permission from the copyright owner or the payment of copyright royalties. To qualify for fair dealing, two tests must be passed.

First, the "dealing" must be for a purpose stated in the *Copyright Act*: research, private study, criticism, review, news reporting, education, satire, and parody. Educational use of a copyright-protected work passes the first test.

The second test is that the dealing must be "fair." In landmark decisions in 2004 and 2012, the Supreme Court of Canada provided guidance as to what this test means in schools and postsecondary educational institutions.

These guidelines apply to fair dealing in non-profit K–12 schools and postsecondary educational institutions and provide reasonable safeguards for the owners of copyright-protected works in accordance with the *Copyright Act* and the Supreme Court decisions.

# Guidelines

- 1. Teachers, instructors, professors, and staff members in non-profit educational institutions may communicate and reproduce, in paper or electronic form, short excerpts from a copyright-protected work for the purposes of research, private study, criticism, review, news reporting, education, satire, and parody.
- 2. Copying or communicating short excerpts from a copyright-protected work under these *Fair Dealing Guidelines* for the purpose of news reporting, criticism, or review should mention the source and, if given in the source, the name of the author or creator of the work.
- 3. A single copy of a short excerpt from a copyrightprotected work may be provided or communicated to each student enrolled in a class or course
  - a) as a class handout;
  - b) as a posting to a learning or course-management system that is password protected or otherwise restricted to students of a school or postsecondary educational institution;
  - c) as part of a course pack.
- 4. A short excerpt means:
  - a) up to 10 per cent of a copyright-protected work (including a literary work, musical score, sound recording, and an audiovisual work);
  - b) one chapter from a book;
  - c) a single article from a periodical;

- d) an entire artistic work (including a painting, print, photograph, diagram, drawing, map, chart, and plan) from a copyright-protected work containing other artistic works;
- e) an entire newspaper article or page;
- f) an entire single poem or musical score from a copyright-protected work containing other poems or musical scores;
- g) an entire entry from an encyclopedia, annotated bibliography, dictionary, or similar reference work.
- 5. Copying or communicating multiple short excerpts from the same copyright-protected work with the intention of copying or communicating substantially the entire work is prohibited.
- 6. Copying or communicating that exceeds the limits in these *Fair Dealing Guidelines* may be referred to a supervisor or other person designated by the educational institution for evaluation. An evaluation of whether the proposed copying or communication is permitted under fair dealing will be made based on all relevant circumstances.
- Any fee charged by the educational institution for communicating or copying a short excerpt from a copyright-protected work must be intended to cover only the costs of the institution, including overhead costs.
