IF Awarded...Community Incentive Grant Program - Municipal

- \$1M annually across the city.
- Central intake and then forwarded to councillor for decisioning mid-September for the following year.
- Project must be initiated within two years of award, and substantially completed within five years of award.
- City of Winnipeg contribution is no more than 50% of total project cost

IF Awarded....From the Ground Up - Provincial

- There are 3 streams: Community Renewal, Community Spaces, Safe, Healthy Connected Children & Youth.
- We are eligible for Community Spaces
- Priority is given to inner-city
- 80% of eligible program costs up to a maximum of \$100,000
- Project can span maximum of 2 fiscal years (April 1 to March 31)
- For projects over \$100,000 two contractor quotes are required. The only other installer approved by the division we can get a quote from is Colcat Enterprises who installs Henderson structures, but they are not module.
