BY-LAW NO. 21

Being a by-law to amend the Board's Procedural By-Law No. 1.

WHEREAS the Legislative Assembly of the Province of Manitoba has amended Section 29 with respect to the timing of the annual election of the Chair and Vice-Chair of the Board, and

WHEREAS the Legislative Assembly of the Province of Manitoba has amended Section 39 of the <u>Public Schools Act</u> and Regulation 201/2004 has received the approval of the Minister of Education, Citizenship and Youth, authorizing school boards to establish a policy permitting Trustees to attend meetings of the Board of Trustees via electronic means,

THEREFORE BE IT RESOLVED THAT the Board's Procedural By-Law No. 1 be amended as follows:

1. Section I, paragraph 1 be deleted and replaced with the following:

"The Inaugural Meeting of the Board shall be held annually:

- a) in a year that a regular election is held, at the first meeting of the Board after the regular elections, and
- b) in any other year, at the first meeting of the Board in September."
- 2. In Section I, paragraph 2, the first sentence be deleted and replaced with the following sentence:
 - "At the Inaugural Meeting, the Trustees shall elect from among themselves a Chair and Vice-Chair who shall hold office until the next election of Chair and Vice-Chair."
- 3. In Section I, paragraph 2, the last sentence be deleted and replaced with the following sentence:
 - "The consecutive number of terms served by the Chair shall not exceed two consecutive terms as Chair and the consecutive number of terms served by the Vice-Chair shall not exceed two consecutive terms as Vice-Chair."
- 4. In Section II add the following as paragraph 9:
 - "On and from the date that the Board gives second and third reading to a policy pursuant to Manitoba Regulation 201/2004 authorizing attendance at a Board Meeting by a Trustee via electronic means, then the term quorum shall mean the number of Trustees physically present at the meeting plus the number of Trustees attending via electronic means."

5. In Section II add the following as paragraph 10:

"Notwithstanding the provisions of this by-law to provide for Trustees to attend Board Meetings via electronic means or Board policy passed pursuant to Manitoba Regulation 201/2004:

- a) each Trustee must be physically present at a regular meeting of the Board at least once every three months as required by Section 39.7.1(2) of the <u>Public Schools Act</u>;
- b) At every Board Meeting the following persons shall be physically present in the meeting room of the Board:
 - i. the Chair, or Vice-Chair or designate;
 - ii. at least one additional Trustee;
 - iii. the Superintendent or designate;
 - iv. the Secretary-Treasurer, Associate Secretary-Treasurer or designate."
