# 1. Recognition of Treaty Land

We acknowledge we are on the lands of Turtle Island where Indigenous Peoples have lived since time began. #### 15.3 Student Travel Insurance

In response to questions from Trustee Karn, the Secretary-Treasurer stated that MSBA made student travel health insurance mandatory in 2022. Initially, the division opted out of the Universal Student Travel Health Plan. Schools were then mandated by the MSBA to purchase the HUB individual travel insurance each time a trip was planned, which was tedious and more expensive to the student travelling. In 2023 the division opted in to the Universal Student Travel Health Insurance, but only students travelling are charged for the insurance allowing a more affordable option for parents. This year there are no increases to premiums and the process remains status quo.
