18. QUESTIONS FROM TRUSTEES

In response to a question from Trustee L. Karn, the Superintendent clarified the acronym TADD stands for Teens Against Drunk Drivers.

In response to a question from Trustee L. Karn, the Assistant Superintendent of Personnel and Education Services stated that the increases in French Immersion and English program students is proportional and holding steady to previous years.

Trustee C. Nachtigall stated that she had an opportunity to speak with the Minister and inquired about the status of the two new K-8 schools for Pembina Trails School Division. She reported that the Minister confirmed that Pembina Trails would not receive funding for the two schools at the present time.

Trustee C. Nachtigall acknowledged and congratulated the organizers and participants of the Fort Richmond Collegiate Career Fair held on April 11, 2024.

In response to a question from Trustee C. Stahlke, the Superintendent stated that she has no further information with regard to available land or the build of a new schools in the Bridgwater Trails area. She informed the Board that the Assistant Superintendent, Personnel and Education Services would begin to model possible scenarios to address the increase in enrolment in the Bridgwater and Prairie Pointe communities should the two K-8 schools be delayed beyond the 2029-2030 school year.

Trustee T. Johnson voiced his disappointment with the Province's decision not to build two K-8 schools in Pembina Trails School Division. He stated that the lack of funding and the decision not to build the two schools will create hardship for the community and make it increasingly difficult for Pembina Trails School Division to meet student transportation needs.

19. QUESTIONS FROM MEMBERS OF THE PUBLIC IN ATTENDANCE

A member of the public asked the Board if there is a relationship between the March 14, 2024, budget that was passed and the Province's decision not to build two new K-8 schools in Pembina Trails School Division by 2027. The Board Chair responded that he was not able to speak to that inquiry.

In response to a question from a member of the public, the Assistant Superintendent, Personnel and Education Services, clarified that his role is focused on teacher retention and standard of behaviour while the Chief Human Resources Officer confirmed her focus is compliance and investigation with all staff.
