#### **1. Recognition of Treaty Land**

We acknowledge we are on the lands of Turtle Island where Indigenous Peoples have lived since time began. These are the ancestral lands of the Anishinaabe, Ininew, and Dakota Nations as well as the traditional trade and travel routes of the Anishininew, Dene, and Inuit. ## **7. DELEGATIONS**

### **7.1 Basic Adult Education**

J. Silver made a presentation to the Board with respect to 2025 survey results from five Manitoba adult learning centres. He reported that earning a mature high school diploma provides personal and family benefits, including increased student engagement among their children. Provincial benefits include fewer people on EI assistance and more in full-time employment opportunities. Mr. Silver requested that the Board write a letter to The Honourable Rene Cable, Minister of Advanced Education and Training in support of Basic Adult Education programming and funding.

### **7.2 Dalhousie Greenspace Initiative**

M. Bueckert, representing the Dalhousie Greenspace Initiative, presented an update on the project and outlined three specific requests of the Board:

1. Approve the project plan in principle to allow the committee to begin fundraising.
2. Support a letter of endorsement from a school principal to enable the committee to apply to the PTESF.
3. Collaborate with division representatives to prioritize the 19 action items outlined in the vision plan.

### **7.3 PTTA**

The PTTA presented to the Board, highlighting the growing and complex needs of students, challenges posed by large class sizes, insufficient funding for resources, and increasing safety issues in classrooms. The PTTA also emphasized the ongoing need for professional development to help teachers address diverse student needs and support personal wellness.

**18. QUESTIONS FROM TRUSTEES**

In response to questions from trustees, the Superintendent provided an update on site development for the new school build, including components from the Province such as outdoor classroom space and field preparation. The next meeting is pending an appeal decision on the 800-seat school, expected by year-end. Tendering is underway, with construction anticipated to begin early winter.

Additionally, the Assistant Superintendent, Inclusive Support Services confirmed that InformNet offers online compulsory courses at no cost to Pembina Trails high school students. Each year, high schools are allocated a set number of seats based on specific school needs and/or enrollment growth. She noted that the cost of courses taken during the summer months is the responsibility of the student.

In response to questions from a member of the public, the Superintendent confirmed that the Provincial request for controlled visitor access is currently focused on grade K-8 schools.
