#### 17. QUESTIONS FROM TRUSTEES

Trustees D. Johnson and C. Jolly brought forward issues raised by parents at the Linden Meadows School parent council meeting held Wednesday, February 8, 2023, regarding adjusted bell times scheduled for September 2023.

The Superintendent acknowledged the challenges families are facing with both early and later start and end times. She explained that Pembina Trails School Division has a hybrid transportation model and employ internal bus drivers as well as contract bus drivers through First Student, who is also affected by the driver shortage as all sectors are competing for the same resources. She also noted that budget constraints present challenges in storing, repairing, and maintaining additional buses concluding that purchasing additional buses and hiring more drivers is not a feasible solution at this time. In response to a question from Trustee C. Jolly, Trustee C. Stahlke explained that bus drivers must possess a class 2 driver's license and undergo training to qualify as a bus driver.

The Superintendent noted that Administration will continue to communicate with families and daycare providers to identify strategies to support families through this transition.
