Notice of Motion

WHEREAS the grade 5 cohort of English Program students at Beaumont School is being split when they move to Westdale School or École Charleswood School for grade 6, and

WHEREAS the grade 8 cohort of English Program students at Westdale School is being split when they move to École secondaire Oak Park High School,

THEREFORE BE IT RESOLVED THAT effective September 3, 2024, the north/south English Program catchment line separating Westdale School and École Charleswood School will be moved to align with the current north/south catchment line separating Beaumont School and Royal School as follows:

- 1. From the intersection of Harstone Road and the Harte Trail, easterly to Buckingham Road.
- 2. Northerly along Buckingham Road to Grant Avenue.
- 3. Westerly along Grant Avenue and turning north to the river, between 4807 Roblin Boulevard and 4727 Roblin Boulevard.

And further;

THAT the north/south English Program catchment line separating École secondaire Oak Park High School and Shaftesbury High School will be moved from Harstone Road to align with the current north/south catchment line separating Beaumont School and Royal School as follows:

- 1. From the intersection of Harstone Road and the Harte Trail, easterly to Buckingham Road.
- 2. Northerly along Buckingham Road to Grant Avenue.
- 3. Westerly along Grant Avenue and turning north to the river, between 4807 Roblin Boulevard and 4727 Roblin Boulevard.

18. QUESTIONS FROM TRUSTEES

In response to questions from Trustees Karn and Jolly, the Superintendent advised that Pembina Trails School Division does not currently have plans to ban the use of cell phones in schools. She stated that educating students regarding appropriate use policies would be the preferred action to address concerns around cell phone usage. The Superintendent informed Trustees that school administrators are not responsible to regulate the use of cell phones in school, however in some cases, the classroom teacher will implement a "no phone use" policy in their classroom. Further, some schools, after consultation with staff, parents/caregivers and students have implemented some guidelines on cell phone use on a school-wide basis.

In response to a question from Trustee Nachtigall, the Superintendent advised that discussions with the Province are ongoing and that currently there is neither a commitment nor change in proposed opening dates from the Province regarding building two new K-8 schools by 2027.
