BY-LAW NO.144

A by-law for the purpose of changing ward boundaries

Being a By-law of the Board of Trustees of the Pembina Trails School Division for the purpose of changing ward boundaries,

**WHEREAS** Section 57(1)(a) of the *Public Schools Act*, Altering the Boundaries of Existing Wards, requires that a change of ward boundaries may be made by Board By-law,

**AND WHEREAS** the Trustees of the Pembina Trails School Division desire to adjust the boundaries of wards one (1) and two (2) to improve the representation quotient,

**AND WHEREAS** it is thus necessary to indicate the boundaries of the ward in the Pembina Trails School Division,

**THEREFORE BE IT RESOLVED:**

**THAT** ward boundaries of the Pembina Trails School Division shall be established in accordance with the following descriptions:

Description of Boundary Change – Tuxedo from Ward 2 to Ward 1

Commencing at the Northwest corner of Park Blvd N. and Wellington Crescent; thence easterly along the centre line of the Assiniboine River to the northerly straight production of the west limit of 123 Doncaster Street; thence southerly along the west limit of 123 Doncaster Street and its straight production to Edgeland Boulevard, continuing southerly on the centre line of Edgeland Boulevard and its straight production to Morpeth Boulevard; thence southerly on the centre line of Morpeth Boulevard to the north limit of 555 Sterling Lyon Parkway; thence westerly along the north limit of 555 Sterling Lyon Parkway and its straight production to Wilkes Avenue; thence westerly on the centre line of Wilkes Avenue to Shaftesbury Boulevard; thence northerly on the centre line of Shaftesbury Boulevard to the centre of the intersection of Shaftesbury Boulevard, Roblin Boulevard, and Corydon Avenue; thence easterly on the centre line of Corydon Ave to the southwestern limit of Park Blvd N.; thence northerly along the along Park Blvd to the point of commencement.

Short Legal Description

Commencing at the northwestern most limit of the property line at the Northwest corner of Park Blvd N and Wellington Cres.

E on Assiniboine River to the northerly straight production of the west limit of 123 Doncaster St.

S along said limit to Edgeland Blvd

Continuing south on Edgeland Blvd to and its straight production to Morpeth Blvd.

Continuing south on Morpeth Blvd to north limit of 555 Sterling Lyon Pkwy

W. along said limit and its straight production to Wilkes Ave.

Continuing west on Wilkes Ave to Shaftesbury Blvd.

N. on Shaftesbury Blvd to intersection of Shaftesbury Boulevard, Roblin Boulevard, and Corydon Avenue

E. on Corydon Ave to southwest limit of Park Blvd N.

N. along Park Blvd N. to point of commencement
